

## eDiscovery DA Receipts and Summary Updates

#### Background Information:

PD Batch Download- This is the Nightly process where CDAC transfers PD Discovery packets directly to the PD's server. This allows them to mass download and provide the discovery internally to their users instead of individiual users downloading packets. All PD users still have access to download packets provided to them at will from the eDisco website, this just provides them another alternative.

Agreement with the PD's Office.

#1. User identify as PD Batch Download is the nightly process that is referenced on your DA Receipt Packets and Summaries.

#2. If the PD Batch Downloader downloads for a packet that will appear in the Download records section. If the current PD attorney listed on your case changes, and a new PD attorney is assigned. They receive notification, the download record will show when it was originally downloaded by this process.

Example:

PD Gagarin Added to Case, Notified on 2/7/2022, the batch Downloader then processed and Downloaded the packet 2/8/2022. PD Dregne is then added to this case 3/11/2022, notification is provided, and the download record would appear with the date of 2/8/2022 as it was previously downloaded. If the PD or their Rep. downloads on the website that is shows with their name under Downloaded By.
